## **FY 2009 List of Obligated Federally Funded Projects**

The Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU) directs MPO's, such as the Kentuckiana Regional Planning and Development Agency (KIPDA), to publish a list of federally funded projects that were obligated in the preceding year. An obligated project is one in which the federal government has made a commitment to pay the federal share of the project cost. KIPDA, cooperatively with the Kentucky Transportation Cabinet (KYTC) and the Transit Authority of River City (TARC), has developed a list of projects that were obligated in fiscal year 2009 for the Louisville (KY-IN) Metropolitan Planning Area. This list of obligated federally funded projects is included in the following table and includes maintenance projects, roadway improvements, transit improvements, pedestrian walkways, and bicycle facilities that were obligated from October 1, 2008 through September 30, 2009.

The projects are shown by county and listed alphabetically by project location. The information that is shown includes the federal funding source, the amount of federal funds that were programmed in the Transportation Improvement Program, the federal funds that were obligated, and the funds remaining for future years. Information concerning the federal obligations was provided by the Kentucky Transportation Cabinet and the Transit Authority of River City.
