Call to Order

Chair J. Byron Chapman called the meeting to order at 10:05 a.m. and introductions were made. It was determined that a quorum was present.

Review and Approval of Minutes

Duane Murner, Oldham County, made a motion to approve the minutes of the October 22 meeting (see November meeting packet). Bob Miller, City of Jeffersonville, seconded the motion and it carried with a unanimous vote.

Public Comment Period

There were no public comments.

Public Meeting/Comment Report

Josh Suiter, KIPDA staff, reported on the following recent and upcoming public involvement activities:

American Recovery and Reinvestment Act (ARRA)

David Burton, KIPDA staff, presented an update on ARRA projects.

Horizon 2030 Transportation Plan and FY 2007-2011 Transportation Improvement Program (TIP)

David Burton and Mary Lou Hauber, KIPDA staff, presented proposed amendments to the long range plan and the short range funding document (see November meeting packet).

Mr. Burton reminded the TPC that this is the last opportunity to amend the long range plan or the TIP before the current long range plan goes into a lapse for 12-18 months due to funding issues associated with the Ohio River Bridges Project.

Ms. Hauber added that some changes to the Plan and TIP can be made as administrative modifications.

J. Byron Chapman, Jefferson County League of Cities, asked for clarification that new projects cannot be added and major changes cannot be made during the lapse. Mr. Burton verified this. Mayor Chapman commented that project sponsors would be “held hostage” for at least a year to a year and a half and asked who could keep the TPC updated on the timeline of the lapse.

Matt Meunier, City of Jeffersontown, asked what determines the length of time of the lapse.

Mr. Burton stated that funding scenarios which pass federal standards need to be identified for the Ohio River Bridges Project. Until that is done, the Plan will be in a lapse. The 12-18 month timeline is an estimate of how long the lapse will last.

Mr. Meunier asked for verification that the length of the lapse is directly tied to identifying a funding mechanism for the bridges project. Mr. Burton verified this.

Larry Chaney, KIPDA staff, stated that the lapse will begin on December 8 and will last at least three to four months because of the time needed for an update of the Plan and TIP to go before the public and then come back to the TPC for review and approval.

Mr. Meunier stated that other projects are not causing the lapse and that it is the bridges project needing to get funding secured that is causing at least a four month lapse in the Plan.

Mr. Chaney stated that this was correct and that the time of the lapse after those four months would be decided by how long it takes to determine a financial plan for the bridges project.

Duane Murner, Oldham County, commented that Mayor Chapman’s statement that project sponsors would be “held hostage” was appropriate. Judge Murner stated that a

12-18 month lapse is an excessive length when caused by an issue which has been recognized for a long time.

Mayor Chapman asked who is in control of the situation. Mr. Chaney indicated that Gary Valentine of KYTC (in attendance) might be able to answer that question.

Amy Thomas, KYTC, wished to clarify that during next 12 months the Plan will be in a lapse, but project sponsors will not be "held hostage" as current projects can continue to move forward and minor changes which meet the requirements of administrative modifications can still be made. However on December 8, 2010 the TIP will also expire. KYTC intends to give direction to KIPDA in the summer of 2010 on the future of the bridges project. On December 8, 2010 the ability to authorize funds will end, resulting in project sponsors actually being "held hostage" since even maintenance contracts cannot be let unless a plan is in place.

Mayor Chapman asked Mr. Valentine if someone from KYTC or the bridges authority would be able to assure the TPC that progress is being made.

Gary Valentine, KYTC, answered that he could not speak on behalf of the bridges authority as the bi-state authority has not yet been established. Indiana still has to nominate members. After the bi-state bridges authority comes together, Mr. Valentine was sure a representative could come before the TPC to discuss their progress.

Mr. Meunier asked if both state governments had given up the ability to identify funding mechanism to the bi-state bridges authority. Mr. Valentine answered that the bridges authority would determine a funding stream with assistance from the two state governments.

Judge Murner asked that the TPC express their frustration, disappointment and anxiety to the KIPDA Board with respect to the indeterminate length of the lapse and how the situation is crippling project sponsors' plans.

Mr. Meunier and Mayor Chapman asked if representatives of both states and/or the bridges authority could come before the TPC in December. Mr. Valentine answered that the bridges authority was scheduled to meet for the first time in December depending on Indiana determining their members.

Mayor Chapman asked if the TPC could set aside the bridges project until a funding stream was determined to allow project sponsors to move ahead with projects and not miss out on money and advancements.

Mr. Burton reminded the TPC that, as Ms. Thomas stated, funding can still be obligated for 12 months after the lapse takes place. However, there will be no opportunities to amend the Plan and TIP. Mr. Burton verified that while the TPC does have the authority to decide which projects are in or out of the Plan, projects cannot be moved in or out of the Plan once the lapse begins.

Mr. Meunier stated that the lapse would last as long as it took for funding to be identified for the bridges project, whether that lasted 12 months, three years, or longer.

Mr. Chaney added that the funding not only has to be identified but also has to be approved by the Federal Highway Administration.

Mr. Meunier asked what would happen if a funding stream could not be determined for the bridges project. Mayor Chapman seconded this question and asked if the lapse could then last forever, since the project could not be moved out of the Plan.

Ms. Thomas assured the TPC that KYTC does not intend to allow the lapse to last longer than next summer, so that when December 8, 2010 arrives, KIPDA will have been given enough direction to know how to move forward with the Plan to allow projects to continue to be authorized. KYTC has no intention of holding hostage this entire area and a decision is expected in the summer of 2010 after the Kentucky General Assembly and the bi-state bridges authority have time to work together on the funding issues.

Mr. Meunier asked if the TPC could send a letter to both states as well as the bi-state bridges authority that the TPC is interested in regular communication after the first of the year. Mayor Chapman agreed that a monthly update is the least that could be done and that the letter requesting this needs to come from the KIPDA Board.

Melanie Roberts, Bullitt County, made a motion to approve the proposed amendments to the long range plan. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.

Bob Miller, City of Jeffersonville, made a motion to approve the proposed amendments to the short range funding document. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.

FY 2007-2011 Transportation Improvement Program

Mary Lou Hauber, KIPDA staff, presented administrative modifications to the short range programming document (see November meeting packet). No action was required.

Congestion Mitigation Process (CMP) Roadway Network

Lori Kelsey, KIPDA staff, presented proposed modifications to the CMP roadway network (see November meeting packet). There was discussion. **Jim Ude, Indiana Department of Transportation (INDOT) – Seymour, made a motion to approve the modifications. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.**

2006 Federal Certification Review

David Burton, KIPDA staff, reviewed and proposed steps for resolution to the Corrective Actions and Recommendations from the 2006 Federal Certification Review (see November meeting packet).

Correction Action 1

Keith Damron, Kentucky Transportation Cabinet (KYTC), stated that KYTC feels that Corrective Action 1 inappropriately focused on internal communication issues at the Cabinet and that the Cabinet speaks with one voice. With that said, Mr. Damon made a motion to approve the recommendations as appropriate in

meeting Corrective Action 1. Jim Ude, INDOT – Seymour, seconded the motion and it carried with a unanimous vote.

Corrective Action 2

Bob Miller, City of Jeffersonville, made a motion to approve Corrective Action 2 as having been met. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.

Recommendation 1

Matt Meunier, City of Jeffersontown, made a motion to approve the proposed process and to direct KIPDA staff to address the proposal as outlined. Duane Murner, Oldham County, seconded the motion and it carried with a unanimous vote.

Recommendation 2

Melanie Roberts, Bullitt County, made a motion to approve the proposed process and to direct KIPDA staff to address the proposal as outlined. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.

Recommendation 3

Duane Murner, Oldham County, made a motion to approve the response as proposed and find Recommendation 3 as being met. Matt Meunier, City of Jeffersontown, seconded the motion and it carried with a unanimous vote.

Regional Transportation Council Working Group. Jim Ude, INDOT – Seymour, seconded the motion and it carried with a unanimous vote.

Indiana Section 5310 – Specialized Transportation Capital Assistance Program Funds

Stacey Burton, KIPDA staff, presented priorities (determined by the Southern Indiana Transit Advisory Group) for the use of Section 5310 funds (see November meeting packet). **Bob Miller, City of Jeffersonville, made a motion to recommend the proposed priorities to INDOT and to certify that projects selected for funding will undergo the TIP amendment process. C. Bruce Traughber, Louisville Metro Government, seconded the motion and it carried with a unanimous vote.**

KIPDA has been informed of administrative modifications to be made to the FY 2007 – FY 2011 Transportation Improvement Program. Administrative modifications are changes that are considered relatively minor and no action is required of the MPO.

Qualifying criteria for administrative modifications include the following actions:

- Correcting obvious minor data entry errors.
- Splitting or combining projects without modifying the original project intent.
- Changing or clarifying elements of a project description (with no change in funding). This change would not alter the original project intent.
- Moving a project from one federal funding category to another except for Surface Transportation Program (STP) dedicated urbanized area funding.
- Moving a project from federal funding to state funding.
- Shifting the schedule of a project or phase within the years covered by the STIP/TIP (with no impact to fiscal constraint).
- Adding Planning, Design, ROW or Utilities “phases” to a construction project that is already included in the STIP.
- Moving any identified project phase programmed for the previous year into a new TIP (rollover provision).
- Updating project cost estimates (within the original project scope and intent) that do not impact fiscal constraint.
