Call to Order

Kevin Baity, Chair, called the meeting to order at 12:31 p.m. After introductions, it was determined that there was a quorum present.

Review and Approval of Minutes

Bill Dieruf, City of Jeffersontown, made a motion to approve the minutes from the May meeting. J. Byron Chapman, Jefferson County League of Cities, seconded the motion and it carried with a unanimous vote.

Public Comment Period

There were no public comments.

Public Involvement Report

Greg Burress, KIPDA staff, reported on activities undertaken to engage the public, comments received, and ongoing and upcoming activities. No action was required.

Quarterly Review of MPO Dedicated Programs

Nick Vail, KIPDA staff, presented a project review, proposed cost increases, and a funding swap to projects funded with MPO dedicated funds. Nominations are due to KIPDA by October 15th. The winning project will be announced at the November TPC Meeting and will be recognized at the KIPDA Boards of Directors Meeting as well.

SUBJECT: KYTC SHIFT 2022 Process

On September 8th, a Working Group of the KIPDA Transportation Technical Coordinating Committee met to select 21 projects to boost for the Kentucky Transportation Cabinet's Strategic Highway Investment Formula for Tomorrow (SHIFT) Process.

The meeting was a hybrid meeting, with some members participating in the KIPDA Burke Room in person and others participating remotely via the Zoom platform. Approximately 80 projects were considered for boosting in Bullitt, Jefferson, and Oldham Counties. Included in the following pages is the file that was an outcome of that meeting showing the 21 projects that the Working Group proposes to boost in the urban KIPDA Counties. The projects that are recommended to be boosted contain a value of "15.00" and are highlighted in gold in the 2022 Local Boost column.

The Working Group used the following to help make the selections:

- The project's score from the SHIFT Scoring System
- The project's score after KYTC District 5 made their selections to boost projects
- The project's ranking from KIPDA's *Connecting Kentuckiana 2040* Scoring System that is utilized for long-range transportation planning efforts
- The project's status (projects that have already progressed through the Right of Way or Utility Phases were prioritized)
- The priority assigned to each project from the KYTC District 5 office
- Was the project considered to be a "Committed Project" by KYTC-Central Office?
- Local priorities

These 21 projects have been recommended to KIPDA's Transportation Policy Committee for approval.

KIPDA has been informed of administrative modifications to be made to the FY 2020-FY 2025 Transportation Improvement Program (TIP). Administrative modifications are changes that are considered relatively minor and no action is required of the MPO Policy Committee.

Qualifying criteria for administrative modifications include the following actions:

- Correcting minor data entry errors.
- Splitting or combining projects without modifying the original project intent.
- Changing or clarifying elements of a project description (with no change in funding). This change would not alter the original project intent.
- Moving a project from one funding category to another.
- Shifting the schedule of a project or phase within the years covered by the STIP/TIP (with no impact to fiscal constraint).
- Adding Planning, Design, ROW or Utilities phases to a construction project that is already included in the STIP.
- Updating project cost estimates (within the original project scope and intent) that do not impact fiscal constraint.
- Adding projects that are considered "grouped projects" that do not require public review, redemonstration of fiscal constraint, or a conformity determination.

The changes to the FY 2020-2025 TIP are being presented to you for your information only. These changes do not affect the fiscal constraint of the Transportation Improvement Program, nor will they affect the progress of other projects in the program.
