SUBJECT: KYTC SHIFT 2024 Process

The Kentucky Transportation Cabinet recently kicked off the 2024 iteration of their Strategic Highway Investment Formula for Tomorrow (SHIFT) Process. This data-driven project prioritization process occurs every two years and will culminate later this year with the development of KYTC's Draft Recommended Highway Plan in advance of the 2024 Session of the Kentucky General Assembly. MPOs have two primary responsibilities in SHIFT: 1) Sponsoring projects, and 2) Boosting projects.

Project sponsorships are allocated statewide amongst the KYTC District Offices, the MPOs, and ADDs. The KIPDA MPO has been allocated up to 49 project sponsorships. A project in our region must be sponsored by KYTC or by KIPDA for it to be considered for scoring in the SHIFT Process. The 49 MPO sponsorships will be in addition to the 67 projects that KYTC District 5 can sponsor across their 8-county district. As has been past precedent, MPO sponsorships will be limited to projects that are in the MTP. With the *Connecting Kentuckiana 2050* MTP scheduled for adoption in May, projects slated for inclusion in that document will be considered.

Project sponsorships are due to KYTC by the end of April. KIPDA staff propose to create a TTCC Working Group consisting of Kentucky agencies only to meet in early April to develop the list of projects to be sponsored by the KIPDA MPO. This group would meet again in the summer to determine the recommended list of projects that get boosted. Boosting gives projects additional points to a small number of projects (the KIPDA MPO has been allocated 18 boosts) indicating their relative local priority.

It is important to note that not all projects are eligible for sponsorship, such as projects determined to be "committed" by KYTC and projects that are programmed to be funded through dedicated funding programs (STBG-MPO, CMAQ, TA-MPO).

SUBJECT: Metropolitan Transportation Plan (MTP) Preliminary Draft Presentation

The update to the KIPDA MPO region long-range plan, *Connecting Kentuckiana 2050* (CK2050) is ready for TPC and TTCC review. Staff requests TPC approval of the draft version in order to start the public outreach process and secure federal approval before June 30, 2023.

Overview of MTP Requirements

CK2050 is the region's Metropolitan Transportation Plan (MTP), also referred to as the long-range plan. The MTP is one of the most important planning functions of an MPO. It is a core federal requirement of MPOs and a precondition for the continued availability of federal funding in a region.

MTPs must follow specific guidelines, including:

- Must have at least a 20-year planning horizon and outline the region's proposed investments in the surface transportation system.
- Must be financially reasonable, meaning expected costs of proposed investments are balanced with realistic revenue expectations from federal financial resources.
- Surface transportation projects in the MPA using federal funds must be incorporated into the MTP and participate in the MPO planning process.
- Updates to the plan are required every four years. Revisions are possible through amendments when there are major changes. Amendments require public review and comment, a redemonstration of fiscal constraint, and possibly an updated air quality conformity determination (in nonattainment and maintenance areas).

CK2050 Overview

Overall, the updated MTP contains 317 projects in the five-county KIPDA MPO region. It estimates federal funding investments in regional transportation to total \$12.4 billion from 2023-2050.

Projects in the MTP were developed over a three-year process that began soon after the previous MTP, *Connecting Kentuckiana 2040* (CK2040), was approved in February 2020. The TPC approved goals, demographic projections, analysis tools, and a new evaluation rubric in stage from 2020 to 2022. KIPDA opened up the project development application window from August to October 2022. This was the process by which local jurisdictions in the KIPDA MPO region and agencies like the Indiana Department of Transportation (INDOT), Kentucky Transportation Cabinet (KYTC), and the Transit Authority of River City (TARC) were able to submit new projects for consideration in the MTP and update existing projects. These submissions and updates are now the projects that make up CK2050.

The CK2050 report is divided into five sections:

- Introduction and what's changed
- Existing conditions report
- Vision, goals, and impact
- Investments (list of projects and description of project selection process)
- Appendices

In addition to the 70 new projects that did not appear in CK2040, core changes in the MTP report itself include:

- An updated project evaluation section that uses the new KIPDA project evaluation rubric to evaluate projects most likely to help advance important regional goals like roadway safety, active transportation, economic development, enhanced movement of freight and others.
- A streamlined project listing section that displays projects in five different categories – transit, roadway, bike/ped, maintenance, and programmatic – and further divides all categories except transit into separate Indiana and Kentucky groupings.
- An expanded existing conditions section that more clearly details regional demographics trends, environmental mitigation issues, and existing conditions across a range of transportation modes.

Next Steps

After the TPC approves the draft version of the MTP, KIPDA staff will open up a 30-day period of public outreach. Upon completion of that 30-day period, the TPC will have 14 days to respond to public comment. After that 14-day period and the addition of any necessary changes to the MTP report, the TPC will reconvene to consider approval of the final plan on May 25. Assuming approval on that date, the approved MTP will be forwarded to USDOT for approval before June 30, 2023, with the plan formally taking effect on July 1, 2023.

- Chapter 5: Project specific reports including the Metropolitan Planning Organization (MPO) Dedicated Funds and the Annual Listing of Obligated Projects;
- Chapter 6: Air Quality Conformity;
- Chapter 7: MPO certification process; and
- Chapter 8: Project listings including project detail tables and maps per project type.

All projects included in the *FY 2023-2026 TIP* are consistent with the *Connecting Kentuckiana 2050* MTP.

TPC and TTCC approval is being requested to take the preliminary draft *FY 2023-2026 TIP* out for public review.

The Unified Planning Work Program (UPWP) identifies the transportation planning activities in the metropolitan area for the year. It is required to include an in-depth description of the activities, the cost to perform these activities, as well as the sources of funding to be utilized to perform the activities.

The UPWP is required to be submitted each year by the end of April, with draft copies submitted for review by the end of February. Staff submitted the Draft FY 2024 UPWP to the State and Federal planning partners as required and are awaiting comments.

SUBJECT: KIPDA Region Safe Streets and Roads for All Grant Award

On February 1, 2023 USDOT awarded the KIPDA region \$600,000 in funding for an action planning grant to significantly reduce roadway deaths and fatalities in the region. Paired with a \$150,000 local match contributed by participating jurisdictions, that funding will enable KIPDA, as the lead agency, to contract with a consulting team to launch the planning process. KIPDA plans to finalize and release an RFQ in the next several weeks. That will likely mean a kickoff date for the planning process in late spring/early summer 2023 though no formal action can start until USDOT approve a grant agreement. At the time of this memo, staff does not know how long the grant agreement process will take to complete but hopes to have more information soon. Once launched, staff anticipates the planning process will take approximately 12 months. Staff will convene the steering committee – made up of representatives from each participating jurisdiction in the next several weeks.

3. Background/review of SS4A grant opportunity

Safe Streets for All (SS4A) is a new competitive grant program established by the Bipartisan Infrastructure Law (BIL) – the recently passed federal infrastructure bill. SS4A grants are intended to improve roadway safety and support efforts to significantly reduce or eliminate transportation-related fatalities and serious injuries involving all roadway users – drivers; pedestrians; bicyclists; public transportation, personal conveyance, and micromobility users; and commercial vehicle operators

Awarded grants will be divided into two primary areas – action plan grants and implementation grants.

- Action plan grants will support a locality or region's efforts to develop, complete, or supplement a comprehensive safety action plan that establishes a well-defined strategy to

prevent roadway fatalities and serious injuries. There is an expected minimum of \$200,000 for all awarded action plan grants and an expected maximum of \$1,000,000 for an action plan grant awarded to a local government and an expected maximum of \$5,000,000 for an action plan awarded to an MPO or a joint application comprised of a multijurisdictional group of entities that is regional in scope (e.g., a multijurisdictional group of counties, a council of governments and cities within the same region, etc.). USDOT encourages action plan grant recipients to apply for implementation grants in the later years of the program.

- Implementation grants support the implementation of projects and strategies identified in an action plan to address a roadway safety problem. Projects and strategies may be infrastructure, behavioral, and/or operational activities. Applicants must have an existing Action Plan to apply for Implementation Grants or have an existing plan that is substantially similar and meets the eligibility requirements. Implementation grant awards are expected to range from \$5,000,000 to \$30,000,000 (for a local government) or \$50,000,000 (for an MPO or joint regional application).

The KIPDA region is not eligible for an implementation grant, but KIPDA staff recommended a region-wide action plan grant application for the following reasons:

- **The region will be eligible for more SS4A funding in the next five years.** Completing an action plan now will put the region in a strong position to win funding for implementation of projects in a relatively short time horizon. With \$5 billion available over five years, this could be an important opportunity to leverage federal funding to implement comprehensive safety improvements throughout the regional transportation network.
- **The region will be better positioned for additional federal funding.** Safety is increasingly one of the top priorities of USDOT. A regional transportation safety action plan will likely not only position the region for future SS4A grants but will position the region to be more competitive for a range of additional funding opportunities.
- **SS4A is an important opportunity to advance safety throughout the region.** Travel doesn't stop at the jurisdictional line, it's regional in nature. But the region does not have a comprehensive region-wide priority list of projects to ensure the safest transportation network possible for residents on both sides of the Ohio. SS4A is a great opportunity to do that and set in motion a generational round of safety improvements.

SUBJECT: Administrative Modifications 43 and 44 to the FY 2020-2025 Transportation Improvement Program (TIP)

KIPDA has been informed of administrative modifications to be made to the FY 2020-2025 Transportation Improvement Program (TIP). Administrative modifications are changes that are considered relatively minor, and no action is required of the MPO Policy Committee.

Qualifying criteria for administrative modifications include the following actions:

- Correcting minor data entry errors.
- Splitting or combining projects without modifying the original project intent.
- Changing or clarifying elements of a project description (with no change in funding). This change would not alter the original project intent.
- Moving a project from one funding category to another.
- Shifting the schedule of a project or phase within the years covered by the STIP/TIP (with no impact to fiscal constraint).
- Adding Planning, Design, ROW or Utilities phases to a construction project that is already included in the STIP.
- Updating project cost estimates (within the original project scope and intent) that do not impact fiscal constraint.
- Adding projects that are considered “grouped projects” that do not require public review, redemonstration of fiscal constraint, or a conformity determination.

The changes to the FY 2020-2025 TIP are being presented to you for your information only. These changes do not affect the fiscal constraint of the Transportation Improvement Program, nor will they affect the progress of other projects in the program.
