#### **CALL TO ORDER**

Chairman Rose called the meeting to order at 1:33 p.m.

#### **ROLL CALL**

Ms. Miller called roll. There was a quorum.

#### **MINUTES FROM OCTOBER 11, 2022**

Mr. Fleming moved to approve the minutes from the October 11, 2022, Regional Water Management Council Meeting. Mr. Bates seconded. Motion carried unanimously on a voice vote.

#### **KDOW & COPPER TEAM UPDATE**

Ms. Elizabeth Dowling, Environmental Scientist with the Kentucky Division of Water (KDOW), gave a presentation on Lead and Copper Rule Revisions. The Lead and Copper Rule Revisions were officially enacted on December 16, 2021, and the first compliance deadline is October 16, 2024. The main provisions of the rule revisions include a Service Line (SL) Inventory. The inventory must include a tap sampling plan and procedures; there is a new definition of tiers of new sampling locations, sample collection protocols, and starting fresh with standard monitoring is now required. The SL Inventory also requires a lead service line replacement plan, and the replacement rate depends on the size of the Public Water System (PWS) and the history of lead compliance sampling. Customers must be kept up to date with the issues and harm caused by lead pipes, and school sampling must take place with sample taps at 20% of daycares and elementary schools annually, starting in 2025. All these items must be completed and submitted to KDOW by October 16, 2024.

A Lead Service Line (LSL) under the Environmental Protection Agency's (EPA) Lead and Copper Rule (LCRR) includes straight sections of line service, utility-owed portions, customer-owned portions, fire service, agricultural/irrigation lines, inactive service lines if still connected to main service lines, and any section of a service line that is made of galvanized iron and has ever been downstream from a lead service line. They do not include lead goosenecks/connectors or service lines installed after January 1, 1988.

The key requirements of the SL inventory include location information for every service line, including sampling point number, if used as a sampling point for compliance; material of every service line, including lead, galvanized requiring replacement, non-lead, and unknown material to be verified at a later date; and the

verification method. The Tap Sampling Plan requires data such as building type, verification of the gooseneck/connector material, lead solder service line verification, tap sampling results, and lead solder in premise plumbing verification. There are five tiers that must be sampled, and all sampling must occur from the highest tier possible.

The Biden-Harris Lead Pipe and Paint Action Plan and the Bipartisan Infrastructure Law (BIL) provides funding for replacing lead pipes nationwide and removal of lead paint in Housing and Urban Development (HUD) approved properties. These measures include an influx of Drinking Water Revolving Loan Fund (DWSRF) money for lead pipe removal, with a focus on lead service lines. The DWSRF funding allotment for 2023 includes:

- \$46,717,000.00 for lead service line projects
- \$29,649,000.00 in supplemental BIL funds
- \$11,547,000.00 base allotment

#### WATER MANAGEMENT COORDINATOR'S REPORT

Mr. Carter stated that this 2023 fiscal year has been very busy so far. There will be a Zoom meeting on January 20, 2022, at 9:30 a.m. with the Kentucky Infrastructure Authority (KIA) to try to get some more information and guidance on the Cleaner Water Program (CWP) grants projects in the KIPDA region that were submitted this past fall. Most of the submitted projects from the KIPDA region were awarded the grant funding that they applied for. There are just a few kinks left to iron out, such as

the level of review that will be required of the projects. This meeting should give the KIPDA Community and Economic Development (CED) division staff a better understanding of the grants and what to expect from the process.

KIPDA CED division staff is also working with the Kentucky Division of Water (KDOW) on State Revolving Fund (SRF) loan projects. There were thirty-two projects from the KIPDA region that were submitted for SRF loan consideration for FY 2023, which is a record number of project submissions. These projects will be included in the KIA Intended Use Plan (IUP), and it should be released by May or June of this year. Mr. Carter reminded the Council members that KIPDA CED division staff would like to receive the mapping information for submitted projects a little sooner this year to accommodate for the project submission deadline. There will likely be a deadline of December 1<sup>st</sup>, 2023 for mapping information next year.

Mr. Carter stated that all the 2023 system visits have been scheduled, and those visits started yesterday. To make the process go more smoothly, Mr. Carter stated that he will email the questions a week or two in advance of the system visits so he can collect the answers necessary for the system data updates at the system visit.

#### **ELECTION OF NEW 2023 KIPDA RWMC OFFICERS**

The Council elected Russ Rose as Chairman and Arthur Jones as Vice Chairman of the KIPDA Regional Water Management Council.

Mr. Bates moved to approve the election. Mr. Fleming seconded. Motion carried unanimously on a voice vote.
