Bridge 51 carrie Blackiston Mill Road over Silver Creek and currently serves as a critical link between the City of New Albany and th Town of Clarksville. The bridge structure itself is the responsibility of Floyd County, with the northern approach being in the City of New Albany and the southern approach in the Town of Clarksville and Clark County. In our 201 Bridge Inspection Report, Bridge 51 scored a 39.2 Sufficiency Rating.
